Carrie Braun, 2457 Shady Court, spoke the she is not in favor of the water/sewer extension. She indicated she is not interested in the potential assessment amount and has fairly new water/sewer systems (approx.. 8 years old).

Supervisor Vandenack made motion to close the floor for public comment. Supervisor Van De Hei seconded the motion. The motion carried unanimously.

Water/sewer extension project and proposed assessments will be reviewed and brought back to the Town Board for July 27th meeting. No official aaction taken.
