6. Consideration of minutes from September 21, 2020 Town Board meeting:

Supervisor Van De Hei made the motion to approve the September 21, 2020 Town Board meeting minutes as presented. Supervisor Vandenack seconded the motion. The motion carried unanimously.

7. Consideration of payment of due invoices and wages:

8. Consideration of Recommendation from Planning & Zoning Board:

Review site plan for new building at 2140 Little Rapids Rd – Bayland Buildings:
Administrator Wetzel gave an overview and drainage plan of the proposed project at 2140 Little Rapids Rd.

Supervisor Vandenack made the motion to approve the concept and site plan for the new building at 2140 Little Rapids – Bayland Buildings as presented. Supervisor Van De Hei seconded the motion. The motion carried unanimously.

9. Consideration of Lawrence Parkway Pay Request #10 – PTS Contractors \$250,853.18:

Supervisor Van De Hei made the motion to approve the Lawrence Parkway Pay Request #10 – PTS Contractors \$250,853.18 as presented. Supervisor Farvour seconded the motion. The motion carried unanimously.

10. Consideration of Carpenter South Change Order – Duplex Lot Water Laterals:

11. Consideration of Barrier Security Quote – Replace Town Hall Door Access Readers - \$3,365:

12. Consideration of Meeting and Conference Room Audio-Visual Upgrades:

Due to the COVID-19 pandemic, the Town has been working through virtual meetings, in-person meetings, and hybrid versions of both in-person and virtual meetings. Funds are available through the federal CARES Act for unbudgeted expenses in dealing with circumstances from the COVID-19 public health situation.

Supervisor Van De Hei made the motion to approve the purchase of the Meeting Owl Pro 360 camera as presented and continue to research other options for audio-visual upgrades. Supervisor Vandenack seconded the motion. The motion carried unanimously.

13. Discussion on Routes to Recovery Grant Eligible Program Expenditures (COVID-19 response):

Due to the COVID-19 pandemic, and subsequent approval of federal CARES Act funding, which has been rolled out at the state level as the Routes to Recovery grant program, funds are available for unbudgeted expenses in dealing with circumstances from the COVID-19 public health situation. The Town of eligible for \$92,500 dollars in the R2R grant program for items purchased between March and November 6th of this year. The Routes to Recover program is strictly for funding of Towns, Cities and Villages. The Town is reviewing expenses and potential needs and will review coordination with school districts on potential school needs through this program.
