There was a discussion about how Lot 1 of the CSM would be rezoned at a later date. Skip Lee made a motion to approve the rezoning of Lots 2 & 3 from ER – Estate Residential – to R1 Residential District, and Lot 4 from ER to R-2 Residential District. Travis Runke seconded the motion. Motion carried.
